## **RESOLUTION NO. 38803**

A RESOLUTION relating to historic preservation; amending the boundaries of the designated historic property known as the J.M. Hendrickson Homestead, located at 1239 East 54th Street, a landmark designated by the Landmarks Preservation Commission under Chapter 13.07 of the Tacoma Municipal Code.

WHEREAS the Tacoma Landmarks and Historic Districts Code,
Chapter 13.07 of the Tacoma Municipal Code ("TMC"), establishes a procedure for
the designation and preservation of structures and areas having historical, cultural,
architectural, archaeological engineering, or geographic importance, and

WHEREAS, on November 29, 2011, the five-acre J.M. Hendrickson Homestead ("Property"), including the house, garage, barn, site, and historic landscaping, was placed on the Tacoma Register of Historic Places, and

WHEREAS the Property is considered historically significant for its association with Tacoma's Scandinavian heritage, as well as its association with Tacoma's farming history, and

WHEREAS, on September 12, 2012, due to unforeseen financial necessity, the Property owner requested feedback from the Landmarks Preservation Commission ("Commission") regarding a proposal to plat a portion of the Property for redevelopment purposes, and

WHEREAS, as a City Landmark, any development on the site is subject to review by the Commission, and

WHEREAS the Commission conducted a site visit on October 3, 2012, and provided additional feedback at its meeting of February 27, 2013, at which time the



Commission recommended that the Property owner submit a proposal to amend the boundaries of the Property, and

WHEREAS the Commission conducted a public hearing on April 10, 2013, to receive public testimony, and notice of the hearing was published and sent to adjacent property owners within 400 feet of the proposed area, and

WHEREAS no comments in opposition were received, and

WHEREAS, on May 8, 2013, the Commission voted to recommend the boundary amendment as proposed to the City Council, and

WHEREAS the proposed boundary amendment will meet the financial needs of the current owner while retaining approximately two acres of open space along with the historic farmstead on the Tacoma Register of Historic Places; Now, Therefore,

## BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

That, pursuant to the provisions of Chapter 13.07 of the Tacoma Municipal Code, the City Council hereby approves the boundary amendment to the designation of the following property as a historic landmark, and maintains said property on the Tacoma Register of Historic Places:
