Project Coordination and Construction for Street Overlay Work - October 28, 2014

SUMMARY:

The Public Works Department recommends that the City of Tacoma (City) and Puyallup Tribe of Indians (Tribe) enter into a Memorandum of Understanding (MOU) regarding project cooperation and construction for street overlay work at East Roosevelt Avenue and Wright Avenue, and the paving of an alley in the 3100 block of East Roosevelt Avenue. The Tribe agrees to pay for the street and alley work, which will be performed in 2015.

STRATEGIC POLICY PRIORITY:

• Plan for and improve public infrastructure that meets the transportation needs of all Tacoma residents and visitors.

This will improve public infrastructure by improving a street and alley that are in desperate need of repair.

BACKGROUND:

The City and the Tribe both recognize and acknowledge opportunities exist in street overlay and alley paving work within the City limits in and around Tribe facilities and tribal residential areas. The City and the Tribe have identified these two areas of right-of-way that are in need of maintenance; the repairs will benefit the City, the Tribe and Tacoma residents and visitors.

ISSUE:

To enter into an MOU with the Tribe to perform street overlay work at East Roosevelt Avenue and Wright Avenue, and alley paving in the 3100 block of East Roosevelt Avenue. The Tribe agrees to pay for the street and alley work.

ALTERNATIVES:

Without the Tribe serving as a funding partner and due to limited financial resources, Public Works will not be able to perform the street overlay and alley paving.

RECOMMENDATION:

The Public Works Department recommends that the City of Tacoma and Puyallup Tribe of Indians enter into a Memorandum of Understanding regarding project cooperation and construction for street overlay work at East Roosevelt Avenue and Wright Avenue, and the paving of an alley in the 3100 block of East Roosevelt Avenue. The Tribe agrees to pay for the street and alley work, which will be performed in 2015.
