Briefing Items

<u>19-0719</u> Closed Captioning in Public Spaces

[Lucas Smiraldo, Management Analyst, Office of Equity and Human Rights]

At approximately 4:36 p.m., Lucas Smiraldo, Management Analyst, Office of Equity and Human Rights, made opening remarks; introduced Todd Holloway, Chair, Tacoma Area Commission on Disabilities; and presented a summary of the request for a closed captioning ordinance.

Mr. Holloway provided background information regarding the history of closed captioning, noting closed captioning may be required for places of public accommodation under the Americans with Disabilities Act (ADA) and not enabling could be considered unlawful or discriminatory. Mr. Smiraldo presented the benefits of closed captioning, including for people who are deaf, seniors experiencing hearing loss, residents learning English, all communities during natural disasters, and individuals needing access to television in noisy environments. Mr. Holloway reviewed examples of other closed captioning models in public spaces. Mr. Smiraldo reported an overview of what has been learned from community engagement, ordinance details, and roll out of the ordinance. Mr. Holloway presented an outline of the number of people who benefit from closed captioning nationally and locally. Mr. Smiraldo concluded by reviewing the economic impact, ordinance enforcement, and a request to support the ordinance.

Discussion ensued regarding an ordinance draft; clarity when drafting the ordinance; the recommended figure for the education campaign; tax and licensing involvement; accessible taxi services; draft ordinance timeline; and fines, enforcement, and compliance of the ordinance.
