Briefing Items

2. 21-0646 Old City Hall Update

[Elly Walkowiak, Assistant Director, Community and Economic Development]

At approximately 10:08 a.m., Elly Walkowiak, Assistant Director, Community and Economic Development (CED), provided opening remarks and introduced Guion Rosenzweig, Project Manager, Old City Hall Renovation. Ms. Rosenzweig presented on the Old City Hall renovation project, including an outline; who the developer and partners are; project summary; permitting; seismic work; special building needs; interior frames for seismic reinforcement; interior frame placement; special features, noting the tower, masonry, bells and clock, terra cotta, copper roof sheathing, windows, safes, jail cells, and original interior finishes; former building uses and renovations; historic tax credits and Tacoma Landmarks Preservation Commission approval; building schematics for cross sectional uses; and a proposed timeline.

Discussion ensued regarding the 1970's era mezzanines, public access, project funding, the clock functionality timeline, clock tower usage, the 19 apartment spaces, public benefit agreement and developer agreements, additional public benefits, posting information on the website, and recognition for Ms. Walkowiak's historic preservation work.

3. <u>21-0648</u>

New State of Washington Tax Increment Financing Law (Enacted May 10, 2021) [Elly Walkowiak, Assistant Director, Community and Economic Development; Andy Cherullo, Finance Director]

At approximately 10:41 a.m., Ms. Walkowiak, Assistant Director, CED, and Andy Cherullo, Director, Finance, presented on the new State of Washington Tax Increment Financing (TIF) law, including an introduction; overview; agenda; background, noting what a TIF is, debt service, exclusions, and incurred debt; issues; allowable uses of the TIF; requirements to create TIF districts; apportionment of taxes; and other considerations.

Discussion ensued regarding a request for more information on potential project areas, the current number of TIF districts, how TIF projects are selected, potential deterrents caused by property tax increases, project scale, timelines for building, taxes within TIF districts, creating a project package for marketing to developers, legislative recommendations to improve how TIF functions, potential competition with Pierce County for TIF allocation, definition of the two allowable TIFs in a jurisdiction, working with

Pierce County for TIF distribution, requirements to create TIF Districts, and a request for a future TIF presentation.

Lynda Foster, Committee Liaison, stated the next meeting will be on July 13, 2021, and will include presentations on workforce recovery, and small business assistance.
