### \*\*\*BACKGROUND



- Original 2021-22 Housing & Urban Development Annual Action Plan (AAP) approved by Council on May 11, 2021
- Amendment to AAP needed to update funding recommendations for Community Development Block Grant (CDBG) Public Services and Emergency Solutions Grant (ESG) projects for 1/1/22 – 6/30/22
  - Original plan stated that approximately 50% of funds would be used to extend contracts for providers receiving 2020-21 CDBG Public Services and ESG funding for an additional six months (July 1, 2021, through December 31, 2021).
  - Remaining funds (approximately 50%) would later be allocated for expenditure from January 1, 2022, through June 30, 2022.\*

Human Services Commission recommended direct allocation of funds in following categories:

#### **CDBG**

- Supportive services for young adults experiencing homelessness who are receiving services at Beacon
- · Street Outreach

#### **ESG**

- · Street Outreach
- · Homelessness Prevention
- Rapid Re-Housing
