FINAL READING OF ORDINANCES

17. **ORD28770**

(Continued from the meeting of September 28, 2021) An ordinance amending Chapter 6A.110 of the Municipal Code, entitled "Property Tax Exemptions for Multi-Family Housing", to eliminate the eight-year Multi-Family Property Tax Exemption in mixed-use centers designated "very high" opportunity, based on the City's Equity Index, effective 90 days after passage of this ordinance.

MOTION: Council Member Ushka moved to refer Ordinance No. 28770 to a Council Committee to be determined by a committee of the chairs of the Community Vitality and Safety Committee, Economic Development Committee, Government Performance and Finance Committee, and Infrastructure, Planning, and Sustainability Committee. Committee chairs will report the assigned committee to the Mayor who will inform the Council. The assigned committee will review and propose recommendations to Ordinance No. 28770 to the City Council at a Study Session or Committee of the Whole meeting no later than October 1, 2021. This will allow us to correlate this with Home in Tacoma Phase I as well as with the roll-out of the affordable housing tax usage.

SECONDED BY: Council Member Thoms.

Mayor Woodards made a friendly amendment to send Ordinance No. 28770 to the Government Performance and Finance Committee, and that all three Chairs working on housing, meet once a month with staff to discuss all the housing issues that are within all three Committees.

The friendly amendment was accepted by Council Member Ushka.
