**Economic Development Committee**

Council Member Hines, Chair of the Government Performance and Finance Committee, reported at today's meeting, the Committee conducted interviews for the Human Resources Director position, and received presentations on Tacoma Public Utilities' Power Note Purchase Agreement, the Manitou Potential Annexation Area, and the monthly budget update. He concluded by stating the next meeting will be held on August 3, 2021, at 10:00 a.m., through Zoom, and will include presentation on Washington State House Bill 1091, public notification processes, and the American Rescue Plan Act funding.
