Tideflats Non-Interim Regulations Review: Fossil Fuel Expansion and Renewable Fuels [Peter Huffman, Director, Planning and Development Services; Steve Victor, Deputy City Attorney, City Attorney's Office]

At approximately 5:04 pm., Chair McCarthy provided opening remarks and a recap of the review meetings held by the Committee so far. Steve Victor, Deputy City Attorney, presented the Tideflats Non-Interim Regulation review definitions, including the terms "renewable fuels" and "clean fuel infrastructure".

Discussion ensued regarding the Clean Fuel Standard (CFS) program, fossil fuels which meet the CFS, credit-generating fuels versus credit-needing fuels, details of the proposed amendments and the Council Members' feedback on them, requests for updates on progress on the Sub Area Plan, implementing a timeline for review, working with the International Maritime Association, the national budget and possible effects on Joint Base Lewis-McChord, and next steps.
