Government Performance and Finance Committee

Council Member Hines, Chair of the Government Performance and Finance Committee, reported at the August 3, 2021, meeting, the Committee received presentations on Washington State House Bill 1091, public notification processes, and the American Rescue Plan Act funding; and at today's meeting, the Committee received presentations on the 2020 audit exit conference, the monthly budget update, the City's draft reserve policy, and deferred repair and replacement project funding. He concluded by stating the next meeting will be held on September 21, 2021, at 10:00 a.m., through Zoom, and will include a presentation on the Multi-Family Property Tax Exemption policy.

Mayor Woodards informed everyone that on August 9, 2021, the City launched the Guaranteed Income demonstration which is called "Growing Resilience in Tacoma", noting the application period, the goal, funding, partnerships, qualifications, and the number of completed and in progress applications. She concluded by stating the applicants will be randomly selected by the University of Pennsylvania and the plan is to have the first payment sent out in October.
