Call To Order

Vice Chair McCarthy called the meeting to order at 10:05 a.m.

Briefing Items

1. 21-0664 Workforce Recovery

[Katie Condit, Chief Executive Officer, Workforce Central]

At approximately 10:05 a.m., Katie Condit, Chief Executive Officer, WorkForce Central, presented on workforce recovery, including an introduction, noting Pierce County system goals, outcomes, services for job seekers, solutions for businesses, and systems alignment; Pierce County labor supply and demand; hiring and layoff aversion; training, upskilling, and reskilling; job seeker support; Pierce County Community Engagement Task Force; and priority populations: youth and adults.

Discussion ensued regarding support for those getting their high school diploma, trend of people changing jobs or not returning to work, growth of demand for WorkForce Central services, the upcoming job fair at the Greater Tacoma Convention Center, outreach announcing that WorkForce Central has reopened, past job fairs, and funding sources of the Bates Technical College and Clover Park efforts.

2. 21-0665 Small Business Assistance [Jeff Robinson, Community & Economic Development Director]

At approximately 10:25 a.m., Jeff Robinson, Director, Community and Economic Development (CED), introduced Dierdre Patterson, Contract and Program Auditor, and Carol Wolfe, Division Manager, CED. Together, they presented on small business financial assistance, including an overview; current City loan programs; a 2020-2021 COVID-19 funding overview, noting sources, and unmet demand in Tacoma; small business recipient demographics, noting ethnicity, woman-owned businesses, percentage of recipients by race, 2020 versus 2021 loan comparison by race, and business type and sector; Equity Index analysis; next steps; Coronavirus Aid, Relief, and the Economic Security Act, and American Rescue Plan Act (ARPA) small business funding.

Discussion ensued regarding whether loan data and grant funding are publicly available to view online, ARPA spending requests for the City Council, offering business grants versus loans, other uses for ARPA funds, next steps and outreach, how the construction industry was impacted by COVID-19, financial support for single owner/employee businesses, potential for cultural ambassadors, the amount of grant applications that were rejected and why, potential creation of a business stakeholders group to direct the ARPA funds, outdoor seating, connecting with employers in the City, and the number of business licenses in Tacoma.
