## COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member McCarthy, Chair of the Infrastructure, Planning, and Sustainability Committee, reported at the August 25, 2021, meeting, the Committee continued the discussion on the Tideflats Non-Interim Regulations; at the August 30, 2021, special meeting, the Committee finalized their recommendations for the Tideflats Non-Interim Regulations and transmitted them to the full City Council on August 31, 2021; at the September 1, 2021, special meeting, the Committee received presentations on the Planning Commission's annual report, the current impact fee

framework, and received several written reports from the Environmental Services Department; at the September 8, 2021, meeting, the Committee conducted interviews for the Transportation Commission and received a presentation on the Home in Tacoma Project; and at the September 22, 2021, meeting, the Committee received presentations on the Climate Action Plan and the Home in Tacoma Project. He concluded by stating the next meeting will be held on September 29, 2021, at 4:30 p.m., through Zoom, and will include continued discussion on the Home in Tacoma Project.

Mayor Woodards stated that the Tacoma-Pierce County Health Department is now operating a temporary isolation and quarantine site at the Lighthouse Senior Activity Center through October 31, 2021; the Lighthouse Senior Activity Center has been closed for senior activities due to COVID-19 since March 2020; the temporary site will provide an additional location to safely isolate and quarantine; due to the increase in COVID-19 cases from the Delta variant, isolation locations have been at capacity; COVID-19 transmission is high in areas with low vaccination rates; 70 percent of eligible residents ages 12 and older in Pierce County are vaccinated. She concluded by providing resources where community members can find more information on the vaccine.
