At approximately 4:38 p.m., Kenny Coble, Community Engagement Coordinator, Media and Communications Office (MCO); Perla Gamboa, Commissioner, Sandra Sych, Vice Chair, and Alma Vargas, Commissioner, Commission on Immigrant and Refugee Affairs (CIRA); and Raeshawna Ware, Senior Policy Analyst, Office of Equity and Human Rights, presented on language access, including an overview, background information, issues, MCO outreach and findings, language access plan, recommendations, next steps, building relationships and trust, and the need to update Tacoma's language access over time to reflect the ever-changing immigrant and refugee populations.  
  
Discussion ensued regarding appreciation of staff for their work, a request to see a draft language access policy, staff recommendations, future budget requests, compensating employees who utilize language skills at work, previous budget approval for a language access coordinator position, future CIRA presentations, building trust with residents, the language access plan, looking at language access more broadly than before, accommodating and celebrating the Lushootseed language, providing multiple language signage, equity and inclusion, reviewing other governments' best practices, and how to move forward with recommendations for the full City Council.

At approximately 5:28 p.m., Bucoda Warren, Strategic Initiatives Coordinator, MCO; and Stephen Hagberg, Chair, Community's Police Advisory Committee (CPAC), provided an update on CPAC, including an overview; the 21st Century Policing (21CP) recommendation document, noting CPAC review and comments; the status of use of force policy review; the Community Trauma Response Team initiative and conclusion, noting the 2016 petition by The Conversation, and CPAC recommendations; updating the City Council on CPAC oversight recommendations, noting the three major types of oversight, short-term CPAC recommendations, the four levels of Tacoma Police Department complaints, and CPAC community engagement

and outreach; and next steps.

Discussion ensued regarding cancelling the November 11, 2021, meeting, 21CP recommendations and CPAC comments, the oversight model, gratitude for the clearly stated opinions of CPAC, community reconciliation, CPAC outreach events, CPAC recommendations for CPAC member appointments, CPAC and Community Vitality and Safety Committee (CVS) having similar interests, and CPAC potentially incubating a non-profit organization.
