1. Call to Order; Roll Call

# 6. Program Updates

Lisa Jaret updated TCAB that the Tacoma Creates Annual Report is close to being done, and that it will be released after staff's presentation to the Economic Development Committee on December 14<sup>th</sup>. She shared a quick preview of the report, and reminded TCAB members that as ambassadors, they can promote Tacoma Creates but are not expected to answer questions beyond their knowledge. Lisa also shared information on the hiring process for the new Tacoma Creates position.

Clarissa Gines then provided updates on the Application Guidelines process, as well as a timeline for the upcoming 2022-23 funding cycle. She also encouraged TCAB members to think about serving on a funding panel. TCAB members asked questions about the application process, which Clarissa answered.

# 7. Action Item

Vice Chair Figueroa gave an overview of the TCAB leadership positions, and election process. She then gave leadership nominees Putter Bert and Sheree Cooks the opportunity to speak on why they are interested in filling a leadership role for TCAB. Vice Chair Figueroa then asked for a motion to approve the slate of Sheree Cooks for Chair, and Putter Bert for Vice Chair.
