#### **SUMMARY AND PURPOSE:**

A resolution authorizing the execution of an Interlocal Agreement with the City of University Place and the City of Lakewood for design of a joint project on South Orchard Street and Lakewood Drive from South 56th Street to South 74th Street.

#### **BACKGROUND:**

This Department's recommendation is based on needed roadway and pedestrian improvements to Orchard Street and Lakewood Drive, a major arterial providing vital mobility connections between Tacoma, University Place and Lakewood. The cities of Tacoma, University Place and Lakewood plan to complete 30 percent design of the roadway and pedestrian improvements to the South Orchard Street and Lakewood Drive corridor between South 56th Street and South 74th Street with the intent of identifying a phased approach for the remainder of design and identification of right-of-way needs for this project. The parties plan on submitting a future joint grant application(s) for federal or state funding for phased improvements to this corridor. The proposed Interlocal Agreement details roles and responsibilities of each party and sharing of design costs with each party responsible for actual design costs in their jurisdiction. The City of Tacoma will be responsible for design costs for the Manitou area of the project currently owned by Pierce County and planned for annexation by the City of Tacoma.

#### **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Infrastructure improvements identified in this proposed Interlocal Agreement were identified by a significant amount of public engagement and outreach in Tacoma completed to develop the Transportation Master Plan. The outreach included engagement in under-represented neighborhoods where improvements historically haven't met expectations with a goal of identifying opportunities in these neighborhoods and helping assure citizens spending is allocated equitably city-wide.

## **2025 STRATEGIC PRIORITIES:**

#### **Equity and Accessibility:**

The proposed resolution will support the City's goals for Equity and Accessibility and Public Works' goals for Access, Traffic Flow and Safety on City streets, pedestrian and bicycle facilities. Infrastructure improvements align with Public Works' Racial Equity Action Plan goals to enhance an organizational culture supporting anti-racist actions and equitable infrastructure investment for the improvements, maintenance, and repair of traffic signal, bridge and other transportation infrastructure in a timely manner affecting all citizens requiring access to a variety of different modes of transportation.

Project outreach is completed through mailings, public meetings and website capital project improvement updates. Project contracts and amendments are presented to the City Council as needed.

#### **STAFF/SPONSOR RECOMMENDATION:**

The Public Works Department recommends authorization of an Interlocal Agreement between the City of Tacoma, the City of University Place and the City of Lakewood to complete 30 percent design of the roadway and pedestrian improvements to the South Orchard Street and Lakewood Drive corridor between South 56th Street and South 74th Street with the intent of identifying a phased approach for the remainder of design and identification of right-of-way needs for this joint project.
