#### Call To Order

Chair McCarthy called the meeting to order at 4:33 p.m.

### **Briefing Items**

1. 21-0823

Tideflats Non-Interim Regulations Review
[Peter Huffman, Director, Planning and Development Services;
Steve Victor, Deputy City Attorney, City Attorney's Office]

At approximately 4:33 p.m., Chair McCarthy provided opening remarks and a summary of the Infrastructure, Planning, and Sustainability Committee meetings held so far regarding the Tideflats Non-Interim Regulations, current staff work, and next steps.

Discussion ensued regarding voting on the proposed recommendations; and issues that arose in stakeholder's meetings that should be considered in the Tideflats Subarea Plan and not the Tideflats Non-Interim Regulations discussion, including regulation of throughput and transhipping, establishing greenhouse gas reduction targets, and industrial insurance and liability.

Steve Victor, Deputy City Attorney, presented the proposed amendments with draft code and definition language, noting permitting new and expanded cleaner fuel facilities; permitting limited petroleum fuel facility expansion; petroleum fuel facility projects for maintenance, safety, security, or that are required to meet regulatory changes; national security petroleum fuel facilities; marine vessels petroleum fuel facilities; and projects which have

undergone environmental review and mitigated impacts.

Discussion ensued regarding comparisons with other jurisdictions, the Washington State Clean Fuel Standard exemptions, noting exemptions and requirements for credit-generating fuels over the life of the program; how the amendments and definitions were created; the enhanced State Environmental Policy Act (SEPA) process; project conditions that will trigger the need for an Environmental Impact Statement; fossil fuel facility and storage expansion; regulations for marine vessels and fuels; how to ensure the City is the lead agency in any SEPA review; determining the need for new or expanded fuel infrastructure; and bringing the Committee's recommendations to the full City Council.
