7. <u>22-0055</u> Feasibility Study for the 5G-enabled Edge computing network for the Tideflats [Pat Beard, Business Development Manager, Community and Economic Development]

At approximately 10:08 a.m., Pat Beard, Business Development Manager, Community and Economic Development, provided opening remarks and introduced Joshua Berger, President and CEO, Washington Maritime Blue. Mr. Berger provided an introduction for Tideflats 5G network feasibility study, and introduced Jim Brisimitzis, Founder, 5G Open Innovation Lab. Mr. Brisimitzis presented a project overview, project partners, and introduced Dustin Stoker, President, Husky Terminal and Stevedoring, LLC. Mr. Stoker presented on Husky Terminal and Stevedoring. Aaron Reich, Managing Director of Emerging Technologies, Avanade, reviewed findings, noting four key themes, including orchestration and efficiency, infrastructure modernization, improving safety, and enabling a sustainable future; and the Tideflats private 5G wireless network. Mr. Berger concluded by outlining next steps.

Discussion ensued regarding expanding the network to other areas of Tacoma, interest of local businesses to join the network, types of businesses and partners the network is trying to attract, and whether the 5G network will create more environmentally friendly jobs.

8. 22-0056 Intro to Healthcare Apprenticeship Pathways Pilot Launch Update
[Bucoda Warren, Strategic Initiatives Coordinator, Media and Communications Office]

At approximately 10:43 a.m., Bucoda Warren, Strategic Initiatives Coordinator, Media and Communications Office, presented an update on the Introduction to Healthcare Apprenticeship Pathways (IHAP) pilot launch, including an overview; background, noting the Tacoma Anchor Institution Network, IHAP stages, cohort start date, paid stipends, and equipment and training; issues; the co-design model; achievements; next steps; and introduced Katie Condit, CEO, WorkForce Central. Ms. Condit further reviewed the co-design model, attention of other local jurisdictions, intent, and introduced Caroline Cabellon, Program Manager - Community Services, Tacoma Housing Authority. Ms. Cabellon presented on the launch of the new Salishan Community Builder position, career pathways, and the 2Gen Family Engagement Program. Mr. Warren concluded by providing an overview of City departments involved in the IHAP program.

Discussion ensued regarding whether there are partnerships with local health providers to coordinate cohort training, and appreciation for the IHAP program.
