Whereas, Wayne Williams was appointed to the Board of Trustees of the Tacoma Public Library on September 27, 2011 by Mayor Marilyn Strickland, and,

Whereas, Wayne Williams was re - appointed to the Board of Trustees of the Tacoma Public Library on September 28, 2016 by Mayor Marilyn Strickland, and,

Whereas, Wayne Williams's second term was extended for three months on July 27, 2021 by Mayor Victoria Woodards and,

Whereas, he has confidently guided the Tacoma Public Library Board of Trustees as Vice President of the Board from May 2015 – September 2018, and,

Whereas, he led the Tacoma Public Library Board of Trustees as President from September 2018, serving in that role through September 2020 and,

Whereas, Wayne Williams worked together with the Board of Trustees through budget challenges and triumphs, technological changes, policy development, community engagement, strengthened partnerships, and a worldwide pandemic, including, but not limited to:

- The refurbishment of the Kobetich, Mottet, Moore, and South Tacoma Libraries, creating more user-friendly and attractive spaces and increasing the number of computers available to patrons;
- Providing convenient library access to all Tacoma Public Schools students through the establishment of the Pathway Card partnership;
- Meeting the challenges of significant technological change, including the transition to a new ILS (Integrated Library System) and VOIP (Voice Over IP) telephone services, the development of a mobile app, and in 2020, a complete technological overhaul, bringing modern and more efficient computing to TPL staff and community;
- The largest grant award TPL had ever received, for the equity-focused Community Archives Center project;
- Providing increased access to library materials through reciprocal agreements with the Pierce County Library System and the Puyallup Public Library in 2013 and with Seattle Public Library in 2021, providing Tacoma residents with access to neighboring library systems;
- Participating in many of 2018's 15 Libraries Transform Tacoma public input meetings, whose
 outcome served as the foundation to a new, comprehensive, community focused strategic plan
 to guide library services through 2025, adopted July 2020;
- TPL becoming an equity-focused organization, joining the Government Alliance on Race and Equity (GARE) in 2019; implementing Normalizing Conversations about Race; and Increasing diversity of hires; modifying policies and practices using an equity lens;
- The restoration of the Assistant Library Director position; and in 2019, Sunday hours at Kobetich, Moore, and Wheelock;
- Strengthened relationships with stakeholders and partners, including the City of Tacoma;
- Increased awareness of library services through effective Social and Traditional Media presence;
- Restoration of the Tacoma Public Library Foundation and its Board of Directors;
- Visits by national dignitaries Michelle Obama and United States Senator Patty Murray;
- The start of a Feasibility Study for the Restoration of Eastside and Hilltop library service, whose branches were closed in 2011 due to budget cuts;
- The suspension of Overdue Fines & Fees; and
- The immense challenge of a global pandemic.

Now, therefore, be it resolved by the Board of Trustees of the Tacoma Public Library that the Board does hereby extend its great appreciation and gratitude to Wayne

Williams for his work as a member of the Board and for his commitment to exemplary library service for the citizens of Tacoma.
