# **Briefing Items**

1. <u>21-1081</u> Interviews for the Community's Police Advisory Committee [Susan D. Haigh, Records Management Supervisor, City Clerk's Office]

At approximately 4:33 p.m., Susan Haigh, Records Management Supervisor, City Clerk's Office, informed the Committee they would be interviewing 12 applicants and reviewing one written response for the Community's Police Advisory Committee. Ms. Haigh further stated that there are eight positions available, including At-Large Nos. 1 through 5, Council District Nos. 1 and 4, and the youth position; but there are only seven positions to consider, as no applicants qualified for the youth position. Ms. Haigh concluded by stating Louis Cooper and Stephen Hagberg are seeking reappointment, and Kathleen Ann Myhre, Brent Riffel, and Braulio S. Aybar did not accept the invitation to interview.

The Committee interviewed Louis Cooper, Stephen Hagberg, Crystal Chatman, Frank D'Andrea, Jabari Hampton, Linda SnowKing "Nikki", Adrian Lavergne, Kevin C Le, Allen McKenzie, Angela J Mealing, Nathan B Robinson, and Lynda Shepherd; and reviewed Keysha-Rae Coopers' written response. Discussion ensued regarding the qualifications of applicants.
