## COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Council Member Hines, Chair of the Government Performance and Finance Committee, reported at the January 18, 2022, meeting, the Committee elected the Chair and Vice Chair; and at today's meeting, the Committee conducted interviews for the Public Utility Board, and received presentations on the monthly budget update, Environmental Service's (ES) issuance of bonds, and the Washington State Auditor's exit conference for the 2018 and 2019 Transportation Benefit District. He conclude by stating the next meeting will be held on February 15, 2022, at 10:00 a.m., through Zoom, and will include presentations on the Rainier Connect contract, and return to in-person meetings.

Council Member Bushnell acknowledged the Lunar New Year, the year of the tiger.

Mayor Woodards provided information on the Summer Jobs 253 program and the partnership with Tacoma Public Schools, noting every student who graduates from high school has an opportunity to obtain an industry recognized certification preparing them for high demand careers after graduation; some of the certifications are embedded in classrooms, including food handlers cards, life guarding, Microsoft Office Professional, Adobe, and automotive; every summer the program offers a certification program in ES, plumbing, pipe fitting, merchant mariner, and Certified Nursing Assistants; during the summer of 2021, the program connected 150 additional students with meaningful paid community service positions where students earned \$1,000 for completing financial literacy training and 40 hours of community service with an organization in their neighborhood; these positions benefit the community service organizations by helping attract volunteers; 2022 marks the ten year anniversary of the program; and the program will be expanding to be year round, to work towards a shared goal of connecting every high school senior with a meaningful work experience before graduating.
