Mr. Morris presented the IT departmental highlight, noting the transformation highlight of digital equity, noting the City Council priority area of access, context, actions, results, and insight. Mr. Key reviewed how the workforce reflects the community, noting the racial and demographic diversity of IT employees, and partnership with Human Resources to address recruitment and the retention cycle; purposeful outreach and engagement, noting the expanded Equity Index tool and improved virtual and hybrid meeting tools; equitable service delivery, noting the process for selecting internal investments; and the departmental look forward, noting next steps. City Manager Pauli concluded by presenting recent accomplishments, upcoming work and engagements, and the transformation timeline and history.

Mayor Woodards requested a follow up of IT's next steps to be presented at a Government Performance and Finance Committee meeting.

### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member Walker, Chair of the Infrastructure, Planning, and Sustainability Committee, reported at the January 26, 2022, meeting, the Committee elected the Chair and Vice Chair and received presentations on industrial symbiosis and the Tacoma-Pierce County Solid Waste Management Plan. She concluded by stating the next meeting will be held on February 9, 2022, at 4:30 p.m., through Zoom, and will include interviews for the Landmarks Preservation Commission.

Council Member Walker announced her participation in the Lute Job Shadow Program at Pacific Lutheran University (PLU) and introduced Stefans Lusis, who is a student at PLU studying strategic communications with minors in business marketing and statistics, and participates in cross country and track. Mr. Lusis expressed appreciation for the Council Members for welcoming him.

Deputy Mayor Ushka addressed comments from Community Forum regarding crime and the TPD, and encouraged everyone to attend their

Neighborhood Council meetings. She concluded by stating the Eastside Neighborhood Advisory Council of Tacoma's next meeting is on Tuesday, February 22, 2022, at 6:30 p.m., and the meeting link can be found at easttacoma.org; and the South End Neighborhood Council's next meeting is on Monday, March 7, 2022, at 7:00 p.m., and their meeting link can be found at senco253.org.

Council Member Hines stated the West End Neighborhood Council is also seeking members, and their next meeting is on Wednesday, February 16, 2022, at 6:30 p.m.

Mayor Woodards stated that COVID-19 is still here, noting cases have dropped more than 30 percent this week, most recent hospitalization cases are from those that are not vaccinated, since the beginning of December unvaccinated people are up to ten times more likely to be hospitalized, and encouraged everyone to reach out to their health care providers or the Tacoma-Pierce County Health Department (TPCHD) to get further information on how to be safe during the pandemic. She concluded by further stating the Washington State Department of Health updated its isolation and quarantine guidelines for childcare facilities to align with K-12 schools, and the TPCHD has adopted the updated guidelines; and reminded everyone to wash their hands, wear their masks, and to get vaccinated.
