Ms. Darlington presented the 2021 audit entrance conference, including an agenda, the 2021 Service Team leads, the scope of services and deliverables, audit timing, planning and risk assessment, the consideration of fraud in a financial statement audit, the audit process, the areas of audit emphasis, and the documents containing audited financial statements and an independent auditor's report.

Discussion ensued regarding input from the Audit Advisory Board before the conference is completed, high risk areas, fiduciary and custodial funds, the Washington State Department of Ecology's acceptable use policy, and uncollected account balances.

 Monthly Budget Update

 [Hayley Falk, Lead Management Analyst, Office of Management and Budget]

At approximately 11:11 a.m., Hayley Falk, Lead Budget Analyst, Office of Management and Budget, presented a monthly budget update, including a new shortcut to the Monthly Financial Report tool on the City's website, cityoftacoma.org/budgetdashboard; the mid-biennium budget modifications will be added to the report in January 2022; the General Fund has a net positive position for October 2021; revenue variances; and Tacoma Venues and Events funds, noting Cheney Stadium and the Greater Tacoma Convention Center.

Discussion ensued regarding whether budget expectations will be reset for the 2023-2024 budget cycle, and the cause of the spike in revenue for Cheney Stadium.

5. <u>21-1215</u> Resolution No. 40884 - Cancellation of Amounts Due per TMC 1.06.226 [Susan Calderon, Assistant Director, Finance]

At approximately 11:18 a.m., Ms. Calderon presented Resolution No. 40884, regarding the cancellation of amounts due per Tacoma Municipal Code Section 1.06.226, including the purpose of the resolution, common practice, typical amounts, and current outstanding balance amounts.

Discussion ensued regarding whether Committee action is required.
