CONSENT AGENDA

1. TCRA Meeting Minutes for March 10, 2022

MOTION: Ian Northrip moved to approve the Consent Agenda as presented. Meredith Neal seconded the motion, which passed unanimously.

ADMINISTRATION

2. 2020 Single Audit Exit Conference

Representatives from the Washington State Auditor's Office presented the Board with preliminary results from the TCRA's fiscal year 2020 state audit and an overview of next steps. No action was taken.

HOUSING

3. Rebuilding Together South Sound (RTSS) Funding Request

Staff presented a funding request to the Board to increase RTSS' current program year contract in support of the Tacoma Home Repair program, to result in eight additional single family home rehabilitation projects.

MOTION: Meredith Neal motioned to authorize TCRA staff to draft and execute an amendment to RTSS' 2021 program year contract that will add \$75,000 in Community Development Block Grant funds, bringing the total contract to \$816,000. \$5,000 will be used for completion of RTSS' federal audit. Lacey Barker seconded the motion, which passed unanimously.

4. Single Family Rehabilitation (SFR) Program Update

Staff provided the Board with an informational presentation on the SFR program's accomplishments to date and objectives for the 2022 program year. No action was taken.
