ORDINANCE NO. 28813

AN ORDINANCE related to the vacation of City right-of-way; vacating the air rights over a portion of South 15th Street, lying between South Court "E" and South Fawcett Avenue, and a westerly portion of South Fawcett Avenue, lying south of South 15th Street, to facilitate design variability for a residential building project; and adopting the Hearing Examiner's Findings, Conclusions, and Recommendations related thereto.

WHEREAS the City received a petition for vacation of air rights over a

⁹ portion of South 15th Street, lying between South Court "E" and South

south of South 15th Street, and

WHEREAS the Petitioner requested the vacation to allow for design

14 flexibility on a residential building project, specifically building façade

That the City Council hereby adopts the Hearing Examiner's Findings, Conclusions, and Recommendations as contained in the Hearing Examiner's Report and Recommendation to the City Council bearing File No. 124.1431 and dated March 28, 2022, which Report is on file in the office of the City Clerk.
