City Manager Elizabeth Pauli provided opening remarks on systems transformation and introduced Ben Thurgood, Assistant Director for Continuous Improvement, and Shelby Fritz, Director, Human Resources (HR). Mr. Thurgood presented the HR departmental highlight, noting the transformation highlight of the Workforce Equity Study, noting the City Council priority areas of belief and trust, and organizational culture; context; actions; results; and insight. Ms. Fritz reviewed how the workforce reflects the community, noting the racial and demographic diversity of HR employees, expansion of the Equal Employment Opportunity program, and completion of a Classification and Compensation Study for non-represented employees; equitable service delivery, noting the launch of an employee learning portal and facilitation of Citywide anti-racist transformation efforts; and the departmental look forward, noting items that are in development. City Manager Pauli concluded by presenting recent accomplishments, upcoming items, and the transformation timeline and history.
