Briefing Items

4. <u>22-0231</u> Sustainable Tacoma Commission Interviews [Doris Sorum, City Clerk]

At approximately 4:35 p.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing seven applicants for the Sustainable Tacoma Commission, including three current members who are seeking reappointment, and that there will be one additional interview at the March 9, 2022, meeting for Brett Marlo, who was unable to attend due to a scheduling conflict. She further stated that there are six positions available, consisting of three member positions for three-year terms, two member positions to fill unexpired terms, and one youth position for a one-year term. She concluded by stating Janeen Provazek withdrew her application from consideration.

The Committee interviewed Matthew Benedict, Kendra Stauffer, Evolondo Cooper, Nikie Walters, Casey McManus, and Laura Svancarek.

Michael Mizer did not attend the interviews.

Discussion ensued regarding waiting until the March 9, 2022, meeting to discuss the applicants and make final decisions.

5. 22-0230 Shipping Containers and Electric Fences Presentation
[Jana Magoon, Planning Manager; Lihuang Wung, Senior Planner, Planning and Development Services; Anna Petersen, Chair; Christopher Karnes, Vice-Chair, Planning Commission]

At approximately 5:39 p.m., Lihuang Wung, Senior Planner, Planning and Development Services (PDS), introduced Jana Magoon, Planning Manager, PDS; and Anna Petersen, Chair, and Chris Karnes, Vice Chair, Planning Commission (PC). Together they presented an update on recent City Council requests regarding shipping containers and electric fences, including an agenda; background; issues, noting both shipping containers and electric fences; the PC's review; and recommended actions.

Discussion ensued regarding current regulations regarding shipping containers, how shipping containers tie into the Home in Tacoma Project, the timeline for the work done by PDS and the PC, the intent of the resolutions, utilizing shipping containers for storage uses versus housing or commercial uses, the PC's amendment process, communication between the City Council and the PC, the PDS work program, fence design standards, possible

processes for gaining permission to build an electric fence, the type of districts electric fences might be necessary in, conditions for installing electric fences, potential costs to small business owners, the issue of property theft, and community outreach and feedback.

MOTION: Vice Chair Hines moved to concur with the Planning Commission's recommendation to move the shipping container topic to the 2023 Amendment docket.
