SUMMARY AND PURPOSE:

An ordinance adopting the draft Six-Year Comprehensive Transportation Improvement Program Amended 2022 and 2023-2028.

BACKGROUND:

This Department's recommendation is based on Section 35.77.010 of the Revised Code of Washington (RCW) that provides that the legislative body of each city and town prepare and adopt a comprehensive transportation program for the ensuing six calendar years and annually thereafter pursuant to one or more public hearings, prepare and adopt a revised and extended comprehensive transportation program, and each one-year extension and revision thereof will be filed with the Secretary of Transportation of the State of Washington. Section 35.77.010 of the RCW further provides that each city will include in their comprehensive transportation program how they intend to expend the revenues for non-motorized transportation purposes.

The City adopted the Transportation Master Plan (TMP) in December 2015, with amendments adopted in June 2018, which includes a prioritized list of transportation projects. The adoption of the TMP included extensive citywide community outreach, including attendance at neighborhood festivals and clean-ups, and two public hearings. The proposed list of projects to be added to the draft Program supports the goals and policies, as well as network priorities outlined in the TMP.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Staff provided a presentation to the Infrastructure, Planning, and Sustainability Committee on the proposed list of projects to be added to, removed from, or consolidated with other projects in the draft program on March 23, 2022 and a presentation on the full draft program on April 27, 2022. Staff also provided a presentation to the Transportation Commission on the proposed list of projects to be added to, removed from, or consolidated with other projects in the draft program on April 20, 2022. A presentation was also provided to the City Council during the May 10, 2022 Study Session. A public hearing is scheduled to be held on Tuesday, June 7, 2022, at approximately 5:15 p.m., at the City Council meeting.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

This ordinance provides the City with an opportunity to implement the TMP that prioritizes mobility for all modes, ages, and abilities with active transportation as the priority.

Explain how your legislation will affect the selected indicator(s).

The draft Six-Year Comprehensive Transportation Improvement Program Amended 2022 and 2023-2028 was developed in concert with the TMP vision that Tacoma is a sustainable community with many drivers, residents, businesses, and visitors who have various transportation priorities. The City is strategic in how it plans its transportation system with an emphasis on carrying the people and goods that foster Tacoma's culture, character, and competitiveness. The transportation system offers multimodal travel options that provide safe access for all users and neighborhoods that encourage healthy living and protect the environment. The projects and programs included in the draft Six-Year Comprehensive Transportation Improvement Program Amended 2022 and 2023-2028 focus on being a partner, protecting the community, providing mobility for all, striving for fiscal, environmental and social sustainability, leveraging programs and services, and linking to land use.
