Briefing Items

1. <u>22-0512</u> Monthly Budget Update

[Hayley Falk, Lead Budget Analyst, Office of Management and Budget]

At approximately 10:05 a.m., Hayley Falk, Lead Budget Analyst, Office of Management and Budget, presented the monthly budget update, including agenda; 2021 year end general fund, noting revenues and expense; and 2022 quarter 1 general fund, noting revenues and expense.

Council Member Walker arrived here, at 10:06 a.m.

Falk continued presenting trends being monitored and the development calendar.

Discussion ensued regarding the parking fund, reserve funds, contingency plans, investing funds, budget modifications and savings, and sales tax.

2. 22-0513 Tacoma Public Utilities Ratemaking Principles
 [Andrew Zaremba, Utilities Economist, Tacoma Water;
 Christina Leinneweber, Senior Utilities Economist, Tacoma Power]

At approximately 10:23 a.m., Jim Sant, Deputy Director, Tacoma Public Utilities (TPU), provided opening remarks and introduced Andrew Zaremba, Utilities Economist, Tacoma Water, and Christina Leinneweber, Senior Utilities Economist, Tacoma Power. Together, they presented the TPU rate-making principles, including an overview, basic principles, TPU principles, rate-making process overview, revenue requirement, cost-of-service (COSA) overview, COSA diagram, using COSA results, and next steps.

Discussion ensued throughout regarding customer classes, residential customers versus industrial customers, and City of Tacoma rates versus other city's rates.

3. <u>22-0514</u> Environmental Services Ratemaking Principles [Christina Curran, Assistant Division Manager, Environmental Services]

At approximately 10:55 a.m., Christina Curran, Assistant Division Manager, Environmental Services (ES), presented ES ratemaking principles, including principles review; strategic plan; ratemaking process; monitoring; and revenue requirement, noting impacts of COVID-19 on revenue requirements.

Mike Slevin, Director, ES, presented capital cost drivers, noting better data, increased costs, timing, and growth; and the 100 year asset plan.

Curran concluded by presenting next steps.

Discussion ensued regarding construction inflation and supply chain issues affecting projects, replacing pipes, and new technologies supporting environmental goals.
