The meeting recessed from time to time based on revisions to the itinerary.

Meeting with various federal legislators or their staff to discuss the City of Tacoma's Federal Legislative Priorities as adopted by Resolution No. 40877, and other matters pertaining to the City of Tacoma.

Sunday, March 13, 2022

The City Council discussed the City's 2022 Federal Agenda, federal lobbying, concerns, and current events, including COVID-19 recovery, systems transformation, Mayors for a Guaranteed Income, immigration reform, gun violence, combating hate crimes, and affordable housing and homelessness.

Discussion ensued throughout regarding the City receiving the second portion of American Rescue Plan (ARP) funds in May 2022 to support

ongoing COVID-19 recovery costs; support of flexible fund dispersal at the discretion of local governments; providing local units of government with direct and flexible recovery funds, including examples of how these have been crucial to the City's ability to provide essential services; the City's commitment to advancing systems transformation with regard to policing and the criminal justice system, economic security, immigration, housing, climate justice, and infrastructure to better support communities that have been under served by existing systems and policies; policing; criminal justice reform; advancing the George Floyd Justice in Policing Act of 2021 in the United States Senate; and supporting issue-specific bills and financial incentives that implement sentencing reform, independent investigations, and body worn camera programs. Discussion continued regarding the City's Growing Resilience in Tacoma pilot program; and immigration reform, noting the Northwest Immigration and Customs Enforcement (ICE) Processing Center, ending the use of privately operated prisons, the Dignity for Detained Immigrants Act of 2021, the New Way Forward Act, the COVID-19 in Immigration Detention Data Transparency Act, and the Federal Immigrant Release for Safety and Security Together Act. Discussion concluded regarding the Bipartisan Background Checks Act, the Enhanced Background Checks Act, concerns regarding crimes in the City targeting religious and ethnic minorities, a national hate crimes commission and database, prioritizing and providing assistance for communities facing homelessness and the housing crisis, and the Howard A. Hanson Dam.
