



ORDINANCE NO. 28823

1 AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the
 2 Tacoma Municipal Code to implement rates of pay and compensation for
 3 employees represented by the International Brotherhood of Electrical
 4 Workers, Local 483, Court Clerks Unit; and declaring the effective dates
 5 thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:

6 Section 1. That Section 1.12.355 of the Tacoma Municipal Code (“TMC”) is
 7 hereby amended, effective retroactive to January 1, 2022, to read as follows:

 21 retroactive to January 1, 2022, to read as follows:

1.12.640 Application of additional rates.

24 4321 An employee in the classification of Court Clerk (CSC 4321) assigned to work as a bailiff in an
 25 assigned court room, shall receive an application of rate of 2 percent above ~~their~~~~his~~~~or~~~~her~~ regular rate of
 26 pay for hours worked while assigned. The application of rate shall not apply to any paid leave time.

4321 An employee in the classification of Court Clerk (CSC 4321) who is certified in an approved
 language and acts as a foreign language interpreter, shall receive an application of rate of 2 percent above



~~their~~ ~~his or her~~ rate of pay for hours worked while assigned. The application of rate shall not apply to any paid leave time.

1 4324 An employee in the classification of Court Financial Clerk (CSC 4324) assigned to work as a bailiff
2 in an assigned court room, shall receive an application of rate of 2 percent above their regular rate of pay
3 for hours worked while assigned. The application of rate shall not apply to any paid leave time.

4 4324 An employee in the classification of Court Financial Clerk (CSC 4324) who is certified in an
5 approved language and acts as a foreign language interpreter, shall receive an application of rate of
6 2 percent above their rate of pay for hours worked while assigned. The application of rate shall not apply
7 to any paid leave time.

9 Section 4. That Section 1 is effective retroactive to January 1, 2022, that
10 Section 2 is effective retroactive to July 1, 2022, and Section 3 is effective
11 retroactive to January 1, 2022.
