Downtown Tacoma Partnership Retail Advocate Update [JD Elquist, Retail Advocate; David Schroedel, Executive Director, Downtown Tacoma Partnership]

At approximately 10:01 a.m. Jeff Robinson, Community and Economic Development Director, introduced JD Elquist, Retail Advocate, Downtown Tacoma Partnership (DTP). Mr. Elquist introduced David Schroedel, Executive Director, DTP, and together they presented a retail advocate update, including the 2018 retail study and strategy, a history of the Business Improvement Area now known as the DTP, noting the goal for a safe, clean, and welcoming downtown; 2019-2021 partners; retail advocacy by the numbers; and future partners.

Discussion ensued regarding the importance of the Tacoma Dome District and Downtown Tacoma, zoning foreshadows, and the inner-urban development; bringing Downtown Works to present to the Committee; great efforts and successes the DTP has had through the COVID-19 pandemic; the two problem buildings; other buildings that have struggled with getting retail into their spaces; how to help with Pioneer Services; economic Opportunity Zones; the Grit City Co-op on South 9th Street and

Martin Luther King Jr. Way; a new location for the Seattle Credit Union; services that can be accessed with the light rail; the 15 percent vacancy that is ready for retail space; and what percentage of the 15 percent can satisfy restaraunt needs.
