Equity in Contracting

At approximately 10:01 a.m. Carol Wolfe, Division Manager, Community and Economic Development, provided opening remarks and introduced Lyle Quasim, Chair, Tacoma-Pierce County Black Collective. Together they presented an update on equity in contracting (EIC), including an agenda; background; Washington Initiative 200; the 2018 Disparity Study; the Community Workforce Agreement Task Force (CWA); work done in 2019; recommendations, noting the phased approach; 2021 activities related to consolidating language and updating the waiver process; 2022 activities to leverage and align programs and waiver analysis; 2022 priorities; establishing the EIC Advisory Committee; recruitment strategies; and next steps.

Discussion ensued regarding EIC capacity building, major recommendations

that have not been codified, trying to get as many contractors from minorityand women-owned businesses into the EIC program as soon possible, outreach and engagement, barriers of working with the government, barriers of paying contractors in a timely manner, Sound Transit, the EIC Task Force versus the CWA Task Force, and overlap between the work of the Joint Municipal Action Committee and the EIC Advisory Committee.
