#### **REPORTS BY THE CITY MANAGER**

City Manager Elizabeth Pauli reported that the Public Works Department received an additional \$1.2 million for phase 2 of the Prairie Line Trail, which is the construction of the shared use path in the Tacoma Brewery District between South 21st Street and South 25th Street along the former BNSF trail line, and will connect the Brewery District, University of Washington Tacoma, and Thea Foss Waterway; and the total project cost is estimated at \$6.5 million; with construction scheduled to be completed by the end of 2023.
