7	WHEREAS the City and the City of Lakewood participate as a consortium
8	in the HOME Investment Partnership Program ("Consortium"), which allows
9	contiguous local governments to take a regional approach to meeting affordable
10 11	housing needs when individual formula allocations do not meet the United States
12	Department of Housing and Urban Development ("HUD")'s minimum threshold
13	for funding, and
14	WHEREAS in September 2021, HUD issued a final notice establishing the
15	requirements for the HOME Investment Partnerships American Rescue Plan
16 17	("HOME ARP") program, with supplemental funding to be allocated as a
18	substantial amendment to the Consortium's 2021-2022 Annual Action Plan
19	("AAP"), and
20	WHEREAS, as the lead jurisdiction for the Consortium, the City convenes
21	planning and reporting for the cities' HOME-funded activities and assumes
22 23	overall responsibility for compliance with the requirements of the program for
24	both cities, and

1 WHEREAS of the total \$5,110,825 assigned to the Consortium, a portion will 2 be dedicated to administration and planning for HOME ARP activities; Lakewood 3 will receive the HUD-recommended amount of 23 percent, and 4 WHEREAS the Consortium proposes to fund the following amounts using 5 its HOME ARP allocation: 1) Administration, in the amount of \$500,000, 6 7 2) Supportive Services (Tacoma), in the amount of \$555,000, 3) Production of 8 Affordable Rental Housing, in the amount of \$3,468,081, and 4) Tenant Based 9 Rental Assistance (Lakewood), in the amount of \$587,744, and 10 WHEREAS on July 26, 2022, the City Council will receive a request to 11 authorize submission of the plan to HUD, and to execute two subrecipient 12 13 agreements: 1) Between the City and the Tacoma Community Redevelopment 14 Authority ("TCRA") to support the production of affordable rental housing and 15 supportive services, and 2) Between the City, the TCRA, and the City of 16 Lakewood to support the production of affordable rental housing and tenant 17 based rental assistance, and 18 19 WHEREAS beginning on July 8, and ending on July 25, 2022, the public 20 was invited to submit comments in writing or in person at a public hearing before 21 the City Council; notification of this comment opportunity was published in The 22 News Tribune and the Tacoma Daily Index, which summarized the contents of 23 the draft allocation plan and outlined instructions for submitting written or verbal 24 25 comments; Now, Therefore, 26

10	Section 2. That the City Manager, or designee, is hereby directed to
11 12	negotiate and execute two subrecipient agreements: one subrecipient agreement
12	with the Tacoma Community Redevelopment Authority ("TCRA"), and one

15	subrecipient agreement with the TCRA and the City of Lakewood, outlining the
16	scope of work and deliverables outlined in Section 1.
