4. BOARD BRIEFINGS

A. 405 Broadway (YWCA Offices) Window grilles

Ms. Johnson outlined the staff report as provided in the packet.

Ms. Weddermann provided information on the campus, including the existing background and motifs and the proposed window grill design. Ms. White provided additional comments on the vandalism, bid information on the proposed like-for-like lower windows, and the need for this change.

Commissioner Williams asked if a plexiglass storm window was considered.

Chair Bartoy requested clarification on the standards applied to this request.

Commissioner Hilsendeger asked about the proposed color for the window grilles and the existing grilles on other windows.

Vice-Chair Mortensen stated she is not opposed to this type of security and referenced the Secretary of the Interior's Standards. She suggested using a more simplified design to match the aesthetics of the building.

Commissioner Sundstrom arrived here at 5:45 p.m.

Commissioner Johnson echoed Vice-Chair Mortensen on the design and stated that it looks vulnerable to vandalism and should be more businesslike, not ornamental.

Commissioner Hilsendeger echoed Vice-Chair Mortensen and Johnson and expressed appreciation for the historic nod in the design.

Chair Bartoy agreed that this type of security coincides with the Secretary of the Interior's Standards and is ok with the current design.

Commissioner Morganroth stated the design is less intrusive and he has no objections to the design.

Vice-Chair Mortensen and Commissioner Johnson clarified her previous comments.

Commissioner Hart suggested looking at motifs and similar elements from buildings in that era and area.

Vice-Chair Mortensen requested clarification on which buildings were the design elements pulled from.

Discussion ensued regarding the simplification of the design, the purpose of the briefing, next steps, and using the Secretary of the Interior's Standards for the Treatment of Historic Properties for guidance,
