I ask for your support for a Council Contingency Fund expenditure of \$10,000 to fund entertainment and arts programming at the 2022 Hilltop Street Fair sponsored by the Hilltop Business Association.

#### **LEGISLATIVE INTENT:**

**Council Contingency Fund Request:** The 7<sup>th</sup> annual Tacoma Hilltop Street Fair is back in 2022 – having last taken place in 2019 due to COVID-19. The mission of the 2022 Hilltop Street Fair is to recover from the pandemic, foster a passion for art, music, and dance in the community, reinvent the Hilltop Street Fair as a signature event, contribute to the Hilltop economy, and rejuvenate the festival with new and lasting inclusion and creativity. The event will take place on Saturday, August 27 from 11am to 7pm on Martin Luther King Jr. Way from South 9<sup>th</sup> Street to South 14<sup>th</sup> Street and at People's Park.

This Council Contingency Fund request of \$10,000 will provide entertainment and arts programming, including, but not limited to costs associated with staging, dance performances, musical performances, children's entertainment, a fashion show, and a talent show. Sponsors for the 2022 Hilltop Street Fair include Tacoma Creates, Virginia Mason CHI Franciscan, Community Health Care, Sound Transit, Tacoma Arts Live, Mi Centro, Little Italy, Bill Korum Nissan, MultiCare, Bates Technical College, Tacoma Housing Authority, and many more. #### **FUNDING REQUESTED:**

\$ 10,000

#### **COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):**

This request for funding came from the Hilltop Business Association who is leading the coordination of the fair. The funding will support the annual community event that benefits those individuals and families that attend the Hilltop Street Fair. The fair is centered on diversity and inclusion of all members of the community, celebrates Tacoma's historically Black neighborhood, and supports the Hilltop economy by inviting people to join in the festivities of this one-day event.

# 2025 STRATEGIC PRIORITIES:

#### Equity and Accessibility:

This Council Contingency Fund request will reduce racial and other inequities to under-served communities by providing generous financial sponsorship to a community event located in the

Hilltop neighborhood – a historically under-served community. Supporting this Council Contingency Fund request will promote equity and inclusion in the Hilltop neighborhood by supporting an important community event for not only members of the neighborhood, but for all community members.

**Economy/Workforce:** *Equity Index Score*: Very Low Opportunity Increase positive public perception related to the Tacoma economy.

#### Livability: Equity Index Score: Very Low Opportunity

Increase positive public perception of safety and overall quality of life.

Explain how your legislation will affect the selected indicator(s)?

This proposal will increase the positive public perception related to the Tacoma economy by supporting an important annual community event in the Hilltop neighborhood that is anticipated to draw over 80 vendors this year and which has convened 20,000 residents in prior years. This proposal will increase the positive public perception of safety and overall quality of life by funding a fun, family-friendly community event in the Hilltop neighborhood.
