

## 6. Discussion/Updates

(1:06:25)

#### a. 'Council Coffee' Meeting Feedback

Staff gave an update about the Council Coffee meetings that were held in May and June. Council Member Walker met with Commissioners Sanchez and Kula. Council Member Bushnell met with Commissioner Neal and Vice Chair Samuel. Commissioner Neal gave an update about the meeting and how Council Member Bushnell is supportive of the Commission and would like to see more focus on the South Hosmer Street area.

## b. Tacoma Arts Month Updates

(1:09:31)

Staff gave a status update on Tacoma Arts Month including the Proclamation at the September 27 City Council meeting with Chair Ben representing the Tacoma Arts Commission; Kaleidoscope opening party on October 5 at STAR Center; and the Tacoma Studio Tour on October 15 and 16 with 54 participating artists at 38 studios. There will also be Arts at the Armory on December 10 and 11. Staff asked for volunteers to help with Tacoma Arts Month materials distribution, staffing at the Kaleidoscope party, and support with digital promotion.

## c. Arts & Economic Prosperity Study

(1:13:43)

Staff gave an update about the Arts & Economic Prosperity (AEP) study. During the first quarter, volunteers attended 9 community events and collected 208 audience surveys. Staff thanked Commissioners for volunteering at events and gave an update about the next set of events. The next step of the study involves compiling a list of all arts and culture organizations in Tacoma. The list will be used to inform the organizational survey portion of the study, which will happen in early 2023.

## d. Diversity, Equity & Inclusion Subcommittee

(1:17:30)

Commissioner Neal gave an update about the work of the Diversity, Equity, & Inclusion (DEI) Subcommittee including discussions around access to public space, meeting with Council Member Bushnell, ways to proactively plan for security at the BLM Mural project, updates to the Gift Policy, and the draft document with anti-racist transformation, equity, and legislation language.

e. Retreat Themes (1:20:58)

Staff gave an update about the themes that came out of the Commission's retreat session. Emerging themes included: Leadership Development and Empowerment, Optimizing Resources: Financial Services, Optimizing Resources: Services, Access & Equity, Visibility, and Policy & Procedure.

7. Staff Check In (1:35:05)

#### a. Staff Projects Overview and Updates

Staff informed Commissioners that meetings will remain virtual for now but that they will eventually move to a hybrid format in the future. The Office of Arts & Cultural Vitality is transitioning from the Tacoma Venues & Events Department to the Community & Economic Development Department.

Staff gave an update about the Tacoma Artists Initiative Project (TAIP) funding cohort meeting. Commissioner Conklin gave an update about her TAIP mid-project meeting with artist Chandler O'Leary. Commissioner Kula had a TAIP mid-project meeting with Rian Kelly.

The 2023 Community Arts Project funding guidelines will be reviewed by the DEI Subcommittee before going to the full Commission at the September meeting.

Twenty-four people registered for Dalisha Phillips' upcoming professional development workshop, Keeping It Cool.

# 8. Public Art Updates (1:42:19)

Staff asked for volunteers to sit on upcoming review panels for several projects including the Tacoma Mall area and the stormdrain mural project with Environmental Services. Staff is working with Public Works on a series of murals for areas heavily hit with graffiti and is seeking panelists. The BLM Mural project is wrapping up and there will be a celebration on August 31 in collaboration with Greentrike's Back to School event. Staff gave an update about the Lushootseed concrete stamp project, featuring artwork by Chris Duenas.

9. Tacoma Creates (1:47:42)

In the 2022-2023 Tacoma Creates funding cycle, 58 arts, culture, heritage, and science organizations were awarded \$4.7 million dollars in funding.
