## **Briefing Items**

3. <u>22-0688</u> Moss Adams 2021 Exit Audit Conference [Olga Darlington, Partner, Moss Adams LLP]

At approximately 10:04 a.m., Olga Darlington, Partner, Moss Adams LLP, presented the 2021 audit exit conference, including the auditor's report on the financial statements; the areas of audit emphasis, noting internal control environment, treasury, capital assets, debt activity, net pension and other post employment benefits liabilities, and revenues and expenses; significant accounting policies and unusual transactions; management judgments and accounting estimates, including risks; uncertainties; and disagreements with management; other communications; audit adjustments and passed audit adjustments; upcoming accounting pronouncements; and acknowledgments.

Discussion ensued regarding management judgment.

4. 22-0689 Tacoma Public Utilities Rate Design
[Andrew Zaremba, Utilities Economist, Tacoma Water;
Christina Leinneweber, Senior Utilities Economist, Tacoma Power]

At approximately 10:23 a.m., Jim Sant, Deputy Director, Tacoma Public Utilities (TPU), provided opening remarks and introduced Andrew Zaremba, Utilities Ecologist, Tacoma Water, and Christina Leinneweber, Senior Utilities Economist, Tacoma Power. Together Zaremba and Leinneweber presented on the TPU rate design, including an overview of the rate-making process, rate design primary takeaways, mismatched costs and revenues, inclining block rate design, fixed versus variable cost recovery, and fixed rates and bill determination.

Discussion ensued regarding rate charging, equity, and affordability; billing fixed costs versus variable costs; and public outreach regarding water.

Leinneweber continued by presenting demand charges; designs used at Tacoma Power, noting two-part versus three-part rates; fixed and variable costs and revenues, customer charges equal electrification costs less, customer charges, noting electrification and heating bills; how customer charges can enhance affordability; and next steps.

Discussion ensued regarding making electric heat cost effective and affordable, offering assistance to residents upgrading power and heating systems for older homes, upcoming plans for public outreach, variable rate changes for residential customers versus industrial customers, practices of

other municipalities, the implementation of advanced metering infrastructure (AMI) and how AMI data can be used, how climate change affects energy demands, and how information is used from variable rates for rate-making decisions.
