## **Briefing Items**

#### 3. <u>22-0748</u> Digital Equity Program Briefing [Kipling Morris, Information Technology Manager, Information Technology Department]

At approximately 10:03 a.m., Kipling Morris, Manager, Information Technology Department, presented the digital equity program, including an overview, background, issues, noting opportunities in areas of control and concern; and next steps.

Discussion ensued regarding how digital programs affect the non-English speaking and less technology savvy populations, public outreach, availability of different languages, expanding the City's portion of the network through different programs, the number of fiber strands that fit through the conduit, how digital and physical space fits together in the City, transforming the City's municipal buildings to better represent the 21st century, and how the City can support public/private partnerships in the City.

#### 4. <u>22-0749</u> Tacoma Public Library & Digital Equity [Kate Larsen, Director, Tacoma Public Library]

At approximately 10:23 a.m., Kate Larsen, Tacoma Public Library (TPL), presented on the TPL and digital equity, including a review of existing services, assisting job seekers with digital skills, virtual services, partnerships, what causes the digital divide, the community impact model, access and training, approaches and assets needed, and possible next steps.

Discussion ensued throughout regarding implementing the model of a common work space for residents, how the cost of digital materials is affecting the budget, bringing a social worker into the library, WiFi hotspots that the library loans out, possible partnerships with Tacoma Public Utilities (TPU), the possibility of Rainier Connect paying for the TPL's internet services, buying digital materials in bulk for a cheaper price, deferred maintence in library buildings, and how the TPL needs more support from the City.
