## **RESOLUTION NO. 41080**

A RESOLUTION relating to historic preservation; adding the proposed landmark to 1 the Tacoma Register of Historic Places and imposing controls for the 2 following property: Virges Apartments, located at 720 6th Avenue; said landmark designated by the Landmarks Preservation Commission under 3 Chapter 13.07 of the Tacoma Municipal Code. 4 WHEREAS the Tacoma Landmarks and Historic Districts Code, 5 Chapter 13.07 of the Tacoma Municipal Code ("TMC"), establishes a procedure for 6 7 the designation and preservation of structures and areas having historical, cultural, 8 architectural, archaeological, engineering, or geographic importance, and 9 WHEREAS, pursuant to TMC 13.07.050, the nomination of the Virges 10 Apartments, located at 720 6th Avenue ("Property"), was submitted by Wright Park 11 Condominium Ownership Group representative Brett Santhuff, for inclusion on the 12 Tacoma Register of Historic Places, along with the requisite application materials, 13 14 and 15 WHEREAS the Landmarks Preservation Commission ("Commission") 16 reviewed the request on September 14, 2022, and held a public hearing on 17 October 12, 2022, to receive public comment on the historic significance of the 18 Property, and 19 20 WHEREAS, according to TMC 13.07.040, the Commission found that the 21 Property meets the eligibility requirements for listing on the Tacoma Register of 22 Historic Places, and 23 WHEREAS, based upon said findings, the City Council believes that it would 24 25 be in the best interest of the City to designate the Property described below as a 26



historic landmark and place it on the Tacoma Register of Historic Places; Now, Therefore,
