## **Briefing Items**

1. <u>22-0797</u> Monthly Budget Update

[Hayley Falk, Lead Analyst, Office of Management and Budget]

At approximately 10:07 a.m., Haley Falk, Lead Analyst, Office of Management and Budget, presented a monthly budget update, including the budget dashboard, noting General Funds, General Fund expense categories, the Tacoma Dome non-general fund, and other expenses.

Discussion ensued regarding actual expenses versus budgeted expenses, if budgeted funds can only be spent on what they were originally allocated for, and ongoing costs.

2. 22-0798 Proposed Changes to the Bill Credit Assistance Plan [Francine Artis, Interim Customer Services Manager, Tacoma Public Utilities]

At approximately 10:16 a.m., Jim Sant, Deputy Director, Tacoma Public Utilities (TPU), introduced Francine Artis, Interim Customer Services Manager, TPU. Artis presented proposed changes to the Bill Credit Assistance Program (BCAP), including a history of utility assistance; customer feedback, noting pros and cons of the program; 2021 enhancements for assistance; current BCAP versus proposed enhancements; customer

success; residential services for income-constrained customers; expansion of water grants and loans, noting program details, program status May 2021 through May 2022, and program expansions in June 2022; expansion of power conservation, noting the energy audit, insulation, and heating and windows; and community partnerships, noting financial education and coaching, and ongoing partnerships.

Discussion ensued regarding community outreach and service availability, BCAP versus BCAP Plus with regards to power credits, application process, the avoided tax on the Bonneville Power Administration incentive funding, and the affordability covenant.

### 3. <u>22-0799</u> Redistricting Update

[Rosa McLeod, Government Relations Analyst, City Manager Office]

At approximately 10:57 a.m., Rosa McLeod, Government Relations Analyst, City Manager's Office, presented a redistricting update, including redistricting efforts; scenario one; redistricting considerations; 6th Avenue Business District; South Tacoma and Pacific Avenue Business Districts; South 56th Street specifics, noting clean and clear dividing lines, and equal populations; and a conclusion.

Discussion ensued regarding reasons for redistricting, map boundaries versus actual perceived boundaries, resident confusion regarding District lines and assigned Council Members, public outreach, feedback, and next steps.
