### **Briefing Items**

1. 22-0857 Business License Fees

[Danielle Larson, Tax and License Manager, Finance Department]

At approximately 10:04 a.m., Danielle Larson, Tax and License Manager, Finance, provided opening remarks and presented an update on business license fees, including an overview; background; issues, noting proposed changes to license fees and gross income tiers, proposed license tiers, and examples of nearby cities and other cities that assess a Business and Occupation Tax, and their business license fees; the health, equity, and sustainability analysis; outreach; and next steps.

Discussion ensued throughout regarding City of Tacoma business license requirements, franchise operators, how the fees are determined, allocation of extra money in the General Fund, community outreach, total anticipated costs, fee changes being passed before the next budget cycle, the impact on business owners and residents who own rental properties, timeline for reexamining fees, and businesses that gross over ten million dollars.

MOTION: Vice Chair Walker moved to forward staff recommendations regarding business license fees to the full City Council for consideration.

2. 22-0859 Tacoma Public Utilities and Environmental Services Budget and Rates Outreach and Communications [John Gaines, Community Relations Manager, Tacoma Public Utilities; Alan Aplin, Account Executive, Environmental Services]

At approximately 10:24 a.m., Jim Sant, Deputy Director,
Tacoma Public Utilities (TPU), provided opening remarks and introduced
Alan Aplin, Account Executive, Environmental Services (ES), and
John Gaines, Community Relations Manager, TPU. Together, they presented
budget and rates community outreach, including an overview; stakeholder
engagement; current outreach environment, noting virtual and hybrid
engagement due to the COVID-19 pandemic; upcoming rates engagement,
noting the planned virtual, hybrid, and in-person engagement plan, and
completed community engagements; and communications and engagement
tools, noting self-serve information and keeping customers informed.

Discussion ensued regarding language access and additional languages being added, how TPU utilizes social media, how public feedback is displayed in the rates, key themes from public feedback, and coordinating outreach with other agencies.
