#### Call to Order

Deputy Mayor Ushka called the study session to order at 12:00 p.m.

## **Briefing Items**

1. <u>22-0826</u> Roadway Renaming Policy

At approximately 12:01 p.m., Josh Diekmann, Interim Director, Public Works (PW), provided opening remarks on the roadway naming policy. Claire Goodwin, City Council Assistant, City Manager's Office, presented the proposed updates to the roadway naming policy, including an overview, background, examples of roadway naming signs, outreach, a summary of the proposed changes, the application materials, special consideration for the Puyallup Tribe of Indians (Puyallup Tribe), and the naming request review process. Diekmann concluded by reviewing the City's partnership with the Puyallup Tribe, and next steps.

Discussion ensued regarding appreciation for staff and the Puyallup Tribe; areas in Northeast Tacoma; the proposal for honorary signs in the Lushootseed language, noting possible locations, process, and funding; the power of place names; opportunities for education and outreach; the difference between honorary versus official roadway renaming; the role of the Landmarks Preservation Commission; historic markers and other decorative signs; temporary versus permanent renaming; honorary place names; and whether multiple languages can be represented on signs.

#### 2. 22-0827 Vision Zero Action Plan

At approximately 12:30 p.m., Deputy Mayor Ushka provided opening remarks regarding traffic collisions, injuries, and deaths in Tacoma, and the Vision Zero goals. Jeffrey Jenkins, Assistant Director, PW, further outlined the City's Vision Zero goal and staff plan, including high risk areas, the equity analysis, and engaging vulnerable and marginalized communities; and expressed appreciation for staff for their engagement efforts. Carrie Wilhelme, Senior Transportation Planner, PW, introduced Michael Hintze, Director of Planning, Toole Design Group, and presented the Vision Zero action plan, including an overview, the global Vision Zero concept, a comparison of the traditional approaches versus the Vision Zero approach, and the City's commitment to have zero traffic deaths and serious injuries by 2035. Hintze reviewed the results of the data analysis and key findings, including how crashes occur, noting overall crash victims, and victims of fatal and severe injuries; and locations, noting that 75 percent of areas with higher crash risk are identified by the City's Equity Index as having low or very low access to opportunity. Wilhelme outlined the public engagement effort, noting the Vision Zero Task Force, survey, interviews, and events; the action plan process; transformative and supportive efforts; and how actions are identified in the plan. Hintze presented the individual elements of the draft action plan. Wilhelme concluded by reviewing Vision Zero benefits and the City's next steps.

Discussion ensued regarding appreciation for staff, the importance of building trust in the community, coordination with Pierce Transit on the Bus Rapid Transit project, separated bike lanes, additional data about high-risk areas and equity, the right-of-way design manual, appreciation for the dashboard and metrics, options to transition the Vision Zero Task Force into an advisory group, strategies to lower speeds on arterial streets, balancing transportation with safety, reckless driving, communicating with the public, how automated traffic camera locations will be selected, accommodating different modes of transportation, the Transportation Master Plan, partnerships with other agencies, equity related to traffic enforcement fines, the proposed Ordinance No. 28825 on tonight's agenda to reduce speed limits, and health equity related to pedestrian access.

#### Other Items of Interest

3. <u>22-0832</u> Council Consideration Request - Peace Bus "Every Kid Eats" Summer Program

Deputy Mayor Ushka presented a Council Consideration Request to allocate \$2,500 of Council Contingency Funds to support The Peace Bus and the "Every Kid Eats" summer program, including the goals to address food insecurity, and information available online at thepeacebus.org. Council Member Daniels stated the funds will help broaden the impact of the grassroots effort, and will contribute to peace and morale in the community.

Discussion ensued regarding support for the request.
