#### 5. DEMOLITION REVIEW

#### A. Gault Middle School

Mr. McKnight read the staff report as provided in the packet.

Ms. Lawver provided information regarding demolition and the release of the Request for Proposal (RFP).

Vice-Chair Mortensen asked which buildings were reviewed and demolished.

Commissioner Williams moved that the landmarks preservation commission recommend the main building of Gault Middle School to be formally reviewed as an individual landmark, including Criteria A, C, and G for significance. Commissioner Hilsendeger seconded the motion. The motion was passed unanimously.

#### 6. DESIGN REVIEW

## A. 811 N. Ainsworth (North Slope Historic District) New construction

Mr. McKnight read the staff report as provided in the packet.

Commissioner Schloesser asked if the applicant is the original demolisher.

Commissioner Cade asked if the elevation that faces Ainsworth was expanded.

Vice-Chair Mortensen noted that there was an addition that was approved but not yet built, which is why the design looks wider. She also stated that she is not supportive of moving the entrance from the front as well as the changed pitches in the roofline. Commissioners Williams and Hilsendeger agreed with Vice-Chair Mortensen.

Commissioner Cade would like to see something like what was approved previously and what was there before. Mr. McKnight spoke to Commissioner Cade's concerns. Commissioner Cade stated that they should restore what should still be there and asked what an appropriate new construction would look like here.

Vice-Chair Mortensen spoke on unsanctioned demolitions. Commissioner Williams echoed Vice-Chair Mortensen.

Commissioner Williams moved that the Landmarks Preservation Commission deny the application as proposed for 811 N Ainsworth. Commissioner Morganroth seconded the motion.

Discussion ensued regarding more clarity that could be provided from the applicant, guidance for the denial, using the original plans from 2016 for reference.

The motion passed with the following votes:

Vice-Chair Mortensen commented on seeing a different front window in the next design.

Commissioner Williams echoed Vice-Chair Mortensen's claims and suggested going back to the 2016 design in order to give proper feedback.

The Landmarks Preservation Commission recessed at 6:48 p.m. and reconvened at 6:54 p.m.

Mr. McKnight outlined the staff report as provided in the packet.

Vice-Chair Mortensen brought up the comment about evidence of redlining and noted that other things have contributed to inequity in housing than just redlining.

Vice-Chair Mortensen moved that the Landmarks Preservation Commission adopt the proposed Findings and Recommendations as presented. Commissioner Williams seconded the motion. The motion passed with the following votes:

Mr. McKnight clarified next steps.
