At approximately 10:01 a.m., Doris Sorum, City Clerk, informed the Government Performance and Finance (GPF) Committee they would be interviewing two applicants for the Board of Ethics (BOE), and that the third applicant, Jennie Dahlby, withdrew from consideration.

The GPF Committee interviewed MarcusAntonio Gunn and Joe Lopez.

Discussion ensued regarding the purpose of the BOE and applicants' qualifications.

2. <u>22-1211</u> Introduction to the Civil Service Board [Shelby Fritz, Director, Human Resources; Eric Hansen, Chair, Civil Service Board]

At approximately 10:21 a.m., Shelby Fritz, Director, Human Resources, provided opening remarks and introduced Eric Hansen, Chair, Civil Service Board (CSB). Together, they presented an informational briefing on the CSB, including an overview, introduction, purpose, membership, and the 2022-2023 work plan.

Discussion ensued regarding residence requirements, review of the City Charter, work done by the CSB, and exempt employees versus appointive employees.

The GPF Committee meeting reconvened at 10:53 a.m.

3. <u>22-1212</u> Code of Conduct for Committees, Boards, and Commissions [Charles Lee, Deputy City Attorney, City Attorney's Office] At approximately 10:53 a.m., Charles Lee, Deputy City Attorney, City Attorney's Office, presented on the proposed code of conduct for committees, boards, and commissions (CBCs), including an overview; and background. He continued by reviewing issues related to CBC conduct, including rules that Tacoma's CBCs must follow, noting governing documents, Resolution No. 36936, and the Code of Ethics in Tacoma Municipal Code (TMC) Chapter 1.46; authorized conduct, noting CBC governing documents and TMC Section 1.46.030; and how other entities have addressed these issues, noting the cities of Lynwood and Bothell.

Discussion ensued regarding members of CBCs identifying themselves when speaking at other meetings, Neighborhood Councils, updating the CBC policies and procedures, hybrid meeting policies, maintaining individual rights for CBC members, and policies of other jurisdictions.
