3. <u>22-1345</u> Community's Police Advisory Committee 2022 End of Year Update

[Ted Richardson, Affordable Housing Action Strategy Coordinator, Media and Communications;

Stephen Hagberg, Chair, Community's Police Advisory Committee]

At approximately 4:39 p.m., Ted Richardson, Affordable Housing Action Strategy Coordinator, Media and Communications Office (MCO), presented an update on the Community's Police Advisory Committee (CPAC) end-of-year report, including an agenda; an overview of CPAC; concluded work, noting a use of force recommendation and a community trauma response team; a comparison of an advisory versus an oversight committee model; the community's objectives for transitioning CPAC's model; models for consideration, noting investigative, review, auditor, and status quo-advisory; community outreach noting details of the community survey.

Chair Ushka arrived here, at 4:49 p.m.

Richardson continued by outlining the survey results. Jacques Colon, Tacoma 2025 Strategic Manager, (MCO) concluded by reviewing next steps.

Discussion ensued regarding the goals and objectives for CPAC, the models for consideration, lack of data available from community participation, the concluded work, the importance of community feedback, and if cities' police forces use the same models, and recruitment to fill youth positions on committee, boards, and commissions.
