SUMMARY AND PURPOSE:

Resolution 39106, a resolution approving the City of Tacoma's Ten-Year Citywide Strategic Plan and Vision (Tacoma 2025), created a Tacoma 2025 Advisory Committee. This resolution would update membership of the Tacoma 2025 Advisory Committee to ensure new Committee membership reflects the geographic, racial, and sector diversity of Tacoma.

BACKGROUND:

This Department's Recommendation is Based On:

Tacoma 2025 requires cross-sector collaboration, and several sectors are currently under-represented in our approach to implementation and redevelopment of Tacoma 2025. As such, we recommend the inclusion of new members that represent workforce and pipeline development, homelessness services, immigrant and refugee services and support, and connections with youth.

The personal and professional experiences of each of the four recommended additions to the Tacoma 2025 Advisory Committee make them well-suited to add crucial perspective to the effective implementation and redevelopment of Tacoma 2025.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The Tacoma 2025 Advisory Committee is an engagement strategy to ensure that input and recommendations around Tacoma 2025 take into account the many diverse perspectives that form our collective vision for Tacoma. Research and engagement were done in partnership with current Tacoma 2025 Advisory Committee members to identify gaps on the current Committee and identify new potential members that would add crucial perspective to the group.

Additional members for the Tacoma 2025 Advisory Committee can be added at any time to continuously improve the diversity of perspectives on the Committee in order to most effectively engage the community moving forward as we redevelop the collective vision for the future of Tacoma.

Decrease the percentage of individuals who are spending more than 45% of income on housing and transportation costs.

Improve health outcomes and reduce disparities, in alignment with the community health needs assessment and CHIP, for all Tacoma residents
