Tacoma Creates Annual Report

At approximately 10:05 a.m., Amy McBride, Arts Administration Division Manager, Community and Economic Development (CED), provided opening remarks on Tacoma Creates and introduced Lisa Jaret, Tacoma Creates Arts Program Administrator, Clarissa Gines, Tacoma Creates Arts Program Planner; and Rico Lastrapes, Senior Management Support Technician, CED; and Sheree Cooks, Chair, Tacoma Creates Advisory Board (TCAB). Together, they presented Tacoma Creates' annual report, including images of events that Tacoma Creates sponsored at various locations; background; an overview of the 2021-2022 program year; primary funding goals; program locations; a financial summary, noting revenues, expenses, and program reserves; youth education programs; education partnerships, noting Tacoma Public Schools and the Tacoma Public Library; equity and access, noting reported evidence of success; TCAB's perspective; and updates and looking ahead.

Discussion ensued regarding the structure of the funding guidelines; capacity expenses; and equity and access, noting community outreach, the ability to rent City facilities, and funding.
