#### **BACKGROUND:**

**This Department's Recommendation is Based On** the statutory requirement that the City appoint members to a "for" and "against" committee when it seeks to place a proposition on the ballot.

On April 18, 2023, the City Council adopted Resolution No. 41180, transmitting a ballot measure concerning restoration of the City's emergency medical services property tax levy, to the Pierce County Auditor to be placed on the ballot for the Primary Election on Tuesday, August 1, 2023.

The Government Performance and Finance Committee reviewed letters of interest at their regularly scheduled meeting on Tuesday, May 2, 2023, and provided recommendations. This resolution would formalize those appointments.

Per RCW 29A.32.280, for each measure from a unit of local government that is included in a local Voters' Pamphlet, the legislative authority of that jurisdiction shall formally appoint a committee to prepare arguments advocating voters' approval of the measure and shall formally appoint a committee to prepare arguments advocating voters' rejection of the measure.

# **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The City reached out to the community to look for those interested in serving on the "for" and "against" committees. The City notified those on the mailing lists from the Tacoma Fire Department, anyone who expressed interest in the past about the topic, and notified those on the agenda notification lists, the Neighborhood Council contacts, and posted the request on the City's notices page. Four people expressed interest in being on the committees, 3 on the "For" committee and 1 on the "Against" committee.

# **2025 STRATEGIC PRIORITIES:**

#### Equity and Accessibility: (Mandatory)

Appointing a "for" and "against" committee is required by state law. It will allow formal support and opposition to the City's request for an increase in property taxes.

### Livability: Equity Index Score: Very High Opportunity

Improve health outcomes and reduce disparities in alignment with the community health needs assessment and CHIP, for all Tacoma residents.
