SUMMARY AND PURPOSE:

The purpose of this item is to Request an Ordinance for a 10 year Telecommunications Franchise Agreement between the City of Tacoma and Sprint (T-Mobile). This is the second such ordinance as the first 10-year agreement (Ord. # 28033) has now expired. We have reviewed their request, negotiated terms, and reached a tentative agreement pending City Council consideration and approval. Based on Sprint's (T-Mobile) Financial and Technical abilities, and having a 10-year History of being a quality provider and vendor in the Public Right of Way in our community, we are recommending passage of this Request for Ordinance.

BACKGROUND:

This Department's Recommendation is Based On State and Local Law which requires a Telecommunications Provider to have a Franchise Agreement to operate in the City of Tacoma Public Right of Way. Sprint (T-Mobile) was granted a 10-year Telecommunications Franchise Agreement (Ord. # 28033) by the Tacoma City Council on December 6 of 2011, which has now expired.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Residents and Businesses in our community will be impacted by this decision as Sprint offers a wide variety of services from Wireline Operations to Wireless Networks, Wireless Wholesale Operations to Mobile Devices and Broadband for the Home.
