

1. Call to Order 5:07 pm (00:00)

## 3. Chair's Report/Housekeeping

Chair Kula led a check-in around the values-based behaviors developed by the DEI Subcommittee in 2022:

- Be willing to experience discomfort and accept differences
- Hold each other accountable with care, being mindful of intentions and context
- Be open to learning; learning is iterative, and perfection is not achievable
- Be a support for each other

Commissioner Williams encouraged Commissioners to read the introduction to Kellie Richardson's book, *The Art of Naming My Pain*, on the subjectivity of safe spaces.

#### 5. Presentations

## a. 2023-25 Tacoma Poet Laureate

(19:27)

Staff introduced Christian Paige, 2023-25 Tacoma Poet Laureate, and Christian gave an introduction and background about himself and delivered a poem. Christian shared his two-part vision for his role as poet laureate: first, that it is important for youth voices to be heard, and second, ensuring that voices of Black, Indigenous, and people of color do not get lost by creating active spaces for these voices. There was a discussion with Commissioners.

Commissioners Brown, Stump, Villeda, and Fernandez-Llamazares volunteered to help at the Pass the Torch event.

## b. Sidewalk Mural in Dome District

(37:05)

Staff introduced artist David Long. David gave a presentation with the background on his proposed sidewalk mural followed by a discussion with Commissioners. There were concerns and questions raised about around the sourcing, authorship, anonymity, compensation, and crediting of people's quotes used in this project. Next step will be voting at the May 8 Commission meeting.

## a. Traffic Box Art Wraps Artist Selection

Staff presented work samples of the 17 artists who were recommended by the panel to create artwork for the 2023 Traffic Box Art Wraps.
